MINUTES

All members of the board were present with the exception of Lyle Guillory. Ryan Robicheaux arrived at 11:12 a.m. Attorney Henry C. Gahagan, Jr., also attended. Guests were Mapes & Mapes and Jayne Segura.

Leigh Lepinski asked for motion for unanimous consent for the waiver of the date, time, place and purpose of the special meeting we called earlier. Motion by James Mitchell. Motion seconded by Gerald Averett, Jr. *Motion passed. No oppositions.*

Leigh Lepinski asked for motion to go into executive session for discussion of litigation against the Fair Grounds in New Orleans, Louisiana at 10:20 a.m. Motion by Mike Hayes. Motion seconded by Larry Findley. 1- Opposition. *Motion passed.*

Leigh Lepinski asked that Henry Gahagan, Jr., Leverne Perry and Tony Patterson attend executive session.

James Mitchell asked that employees of the LQHBA Office be able to stay in the executive session. No oppositions.

Motion by Jimmie Hatcher to go into regular session at 12:31 p.m. Motion seconded by Julien Stevens, III. *Motion passed. No oppositions.*

Leigh Lepinksi asked that Mapes & Mapes speak to the LQHBA board at this time because of prior engagements they have.

Motion by James Mitchell to adopt the resolution to the La. R.S. 27:438 legal action concerning The Louisiana Quarter Horse Breeders Association, represented by its duly authorized Executive Secretary, Tony Patterson, be and it is hereby authorized to engage Kelly and Townsend, Attorneys at Law, 137 St Denis St., Natchitoches, LA 71457 and Henry Cole Gahagan, Jr. (A.P.L.C.), P. O. Box 1188, Natchitoches, LA 71458-1188, together with any other attorneys, accountants, forensic experts, or other professionals (Professionals") upon reasonably commercial terms and conditions to represent the Association against the Fair Grounds Race Track (its related business interest), the HBPA as well as any other party who may be liable and to pursue an action having as its purpose, i) declaring the rights, status, and other legal relations by and between the Fair Grounds Race Track (its parent organizations of related business interests) insofar as the payment of revenues from OTB video poker devices earned for purse supplements for the benefit of all breeds of horses that race at the Fair Grounds Race Track and the respective horsemen, 2.) an accounting of revenues from OTB video poker devices owned by the Fair Grounds or its related business interests for the benefit of all breeds of horses that race at the Fair Grounds Race Track and their related horsemen, 3.) damages for the non-payment by the Fair Grounds Race Track (its parent organizations or related business interests) of revenues earned during any period of time for purse supplements for the benefit of all breeds of horses that race at the Fair Grounds Race Track and their related horsemen, together with any and all such other relief and enforcement of judicial rights which the said attorneys deem actionable under the laws of the United States and the State of Louisiana. Motion seconded by Gerald Averett, Jr. Motion passed. No oppositions. (12 for)

Motion by James Mitchell to amend the LQHBA by-laws by adding Article XIII, Indemnification of Officers and Directors as follows:

XIII. INDEMNIFICATION OF OFFICERS AND DIRECTORS

The corporation shall indemnify and hold harmless each director and officer now or hereafter serving the corporation from and against any and all claims and liabilities to which he may be or become subject by reason of his now or hereafter being or having heretofore been a director or officer of the corporation and/or by

reason of his alleged acts or omissions as such director or officer, whether or not he continues to be such director or officer, at the time when any such claim or liability is asserted, and shall reimburse each such director and officer for all legal and other expenses reasonably incurred by him in connection with defending any and all such claims or liabilities, including amounts paid or agreed to be paid in connection with reasonable settlements made before final adjudication with the approval of the board of directors, whether or not he continues to be such director or officer at the time such expenses are incurred; provided, however, that no director or officer shall be indemnified against any claim or liability arising out of his own willful misconduct or shall be indemnified against or reimbursed for any expenses incurred in defending any such claim or liability or in settling the same unless in the judgment of the directors of the corporation the director or officer against whom such claim or liability is asserted has not been guilty of willful misconduct. The foregoing right of indemnification shall not be exclusive of any other rights to which and director or officer may be entitled as a matter of law. The directors and officers of this corporation are authorized to purchase insurance to indemnify them against liability for their acts. (Adopted February 1, 2014)

Motion by James Mitchell to amend the LQHBA by-laws by adding Article XIV. Payment of Breeder Awards as follows:

XIV. PAYMENT OF BREEDER AWARDS

The board of directors shall fix the amount of breeder's awards to be paid by the corporation. Any such breeder awards shall first be budgeted for payments to the breeders of Louisiana accredited quarter horses which are otherwise eligible for payment in the current year or racing season in which such sums are budgeted.

The board of directors may also pay any breeder awards owed to breeders of

Louisiana accredited quarter horses for prior years but only after all breeders awards are paid to breeders for the current year or racing season. In the event of the application for or claim of entitlement to breeder awards for prior years or racing seasons, the board shall consider the corporation's retained earnings, estimated revenues dedicated for such all breeder awards and any and all other resources of the corporation which the board of directors, exercising its best business judgment deems meet and proper. (Adopted February 1, 2014)

Motion seconded by Julien Stevens, III. Motion passed. No oppositions. (12 for)

Henry C. Gahagan, Jr., asked the LQHBA board to clarify the motion by Lyle Guillory on paragraph six (6) on the minutes from December 10, 2013, LQHBA Board of Directors meeting.

That a letter be directed to the HBPA which I have displayed to the board was in fact submitted on November 9, 2013 and I believe the paragraph should be amended such that in the event that the demand to the HBPA in the event we have no results then Don Kelly and Henry Cole Gahagan, Jr. would meet with the members of Louisiana Quarter Horse Racing Association (LQHRA) and tell the horsemen the purpose of discussing different strategies. I ask that you consider that amendment.

Leigh Lepinski and Leverne Perry arrived at 10:49 a.m. Attorney Henry C. Gahagan, Jr., also attended. Guests were Harold Forman, David Tillson and Foster Bridewell arrived at 1:36 p.m.

Lyle Guillory requests that Mapes & Mapes be added to notification of LQHBA Board of Directors meetings.

Motion by Lyle Guillory to accept the minutes from the December 10, 2013 and February 1, 2014 meetings. Motion seconded by Arnold Trahan. *Motion passed. No oppositions.*

Motion by Gerald Averett, Jr. to accept the video poker audit prepared by Paul Dauzaut, CPA. Motion seconded by Michael Hayes. *Motion passed. No oppositions.*

Tony Patterson asks the LQHBA Board of Directors to have a financial management audit of the LQHBA Association.

That we continue to watch, send letters out to our membership to make sure all necessary controls are in place to handle these bills if something were to happen and we want to bring this back up again. I don't think we need to do anything different, stay aggressive and try to get these Bills killed. We don't need to relax, we need to continue forward and stay on top of these bills.

Use breeders award interest that has been accruing since 2002 for income. The total of \$484,590.95. Attorney Henry C. Gahagan, Jr. suggests that we don't move all the money at one time. He would transfer \$75,000 this year and see how the auditor responds.

Motion by Gerald Averett, Jr. to adopt Attorney Henry C. Gahagan, Jr. recommendation to amend the 2014 budget to recognize an increase in revenue. Motion seconded by Michael Hayes. *Motion passed. No oppositions.*

Larry Findley ask to recess at 11:30 a.m. to break for lunch.

Larry Findley called meeting back to order at 12:29 p.m.

Lyle Guillory gave the sale committee report. 1. Credit card machine at the sale. 2. Spanish speaking person at a welcome booth and in the sales office. 3. Have an emergency area. 4. Major bank for wire transfers. 5. Transportation of money back to our bank or back to Alexandria. 6. Horse being held after the sale. (Lynn Richard's Farm) 8. All members of the board were present with the exception of Gerald Averett, Jr., Jimmie Hatcher, Mark Petry, and Ryan Robicheaux Jim Mitchell, Mark Petry, R. L. (Lynn) Richard and Ryan Robicheaux. Leigh Lepinski and Leverne Perry arrived at 10:40 a.m. Kenny Patton arrived at 10:51 a.m. Attorney Henry C. Gahagan, Jr., was on conference call line along with Ryan Robicheaux, Gerald Averett, Jr., and Jimmie Hatcher attended. We have a quorum (9).

Tony Patterson purposed an amendment to the LQHBA bylaws article: 4 section 1 & 6. That a board member may attend a special meeting by conference call.

2 proposals given by Attorney Henry C. Gahagan, Jr.

It is a reasonable business practice to enable board members to participate in special board meeting by telephone as long as they register their attendance and no objection to the meeting being held in that manner and participate in the discussion such that they can cast an informed vote. It is an almost universal practice now for the board of directors to accommodate directors who live away or on vacation, or ill, an opportunity to participate by telephone and to cast their vote as if they are present. That is the suggestion I make to the board will require an amendment to the bylaws so that is issue number one.

I made a suggestion that if at this emergency meeting there was a quorum we could do one of two things. Number one, we could discuss It and we could vote on it as a recommendation to be taken up at the full regular board meeting in June or we could go ahead and cast it so we can go ahead and conduct business and have a full vote on the issues to be brought before the board to include those members that participate by telephone. So issue number one is to amend the bylaws and enable the participation for emergency and special meetings by the board members by the telephone. That is my first recommendation.

I will provide the full language for you at the next meeting.

Adopt the bylaw recommendation today.

Motion by Lyle Guillory to accept Mr. Henry C. Gahagan, Jr's first proposal of having a LQHBA director be able to attend an emergency or special meeting by phone and be able to cast their vote as long as there is a quorum in person or by phone. Motion was seconded by Shawn Magee. *Motion passed. No oppositions.*

Second recommendation to the LQHBA board is to differentiate between regular, special and emergency meetings. I think that regular meetings are the ones that Larry Findley called upon at the last board meeting in Opelousas where we regularly schedule quarterly or semi-annual meetings in addition to the annual membership meeting. The idea of having an emergency meeting to me has a bad taste in my mouth. It's as if you have some kind of emergency where someone got killed that you have to take immediate action to remedy that problem. I would like to have three classes of meetings. The first is a regular meeting that is scheduled on the calendar. The second is that I would suggest to the board that you have a special meeting with not less than three days notice in writing to the board members to give you a chance to consult amongst each other and to fully grasp and comprehend the issues. Three or five day's written notice. The third would be a true emergency meeting that something has happened so rapidly that you have to have to have a 24 hour or 12 hour resolution to a problem. I'm think specifically of legislative issues or financial issues that come up that require immediate attention from the board. I'm recommending to you to redefine the types of meetings the regular, and special with written notice in a certain number of days within which to have a chance to review what is to be taken up at that special meeting. Third, a true emergency meeting that can be held on 12 hour or 24 hour notice. That is my recommendation to you.

Motion by Lyle Guillory to accept Mr. Henry C. Gahagans, second recommendations on the types of board meetings. Motion seconded by Lynn Richard. *Motion passed. No oppositions.*

I will provide the full language for you at the next meeting.

I'm ready to discuss at any time the amendment to the Coushatta Tribe lease that I was instructed to prepare and circulate to Larry Findley and Tony Patterson and then to the Coushatta Tribe, so I'll be happy to take it up now or happy to call back in later.

Tony Patterson asks to take a 20 minute break at 11:00 a.m. and notify the other board members that they can join in on the meeting at 11:20 a.m.

The quarter horse weanlings and yearlings could possibly sellfirst.

Limit quarter horses to 150 & thoroughbreds 150 consignments.

The consignors will pay \$20 per stall for stall shavings and cleanout.

Raise the consignment fee to \$250 per consignment and not charge the consignor \$20 shavings & cleanup fee.

The Coushatta Tribe has applied a \$500 fine for any permanent stall that is disabled at any sale at their facility. This fee will be passed on to the consignor. This notification will be passed on to the consignor at the time of their hip number notification.
