There shall be no refund of nomination or sustaining payments for horses that fail to meet the required qualifications. All owners must be a current member of the LQHBA. Membership can be purchased at time of nomination. Six percent (6%) will be deducted from the total payments for administration fees. Please see reverse side for full conditions of the race.

Only Accredited Louisiana Bred foals of 2015 that entered the 2016 LQHBA Yearling Sale or the 2015-2016 LQHBA Fall Mixed Sale and passed through the sale ring (sold or repurchased) and are paid to date in the 2017 LQHBA Futurity & Invitational stakes are eligible for nomination to this futurity.

Purse Distribution

Six percent (6%) shall be deducted from the total futurity payments for administrative fees.

The nominator represents that he/she and all persons for whom he/she is acting have read and are familiar with the rules and regulations of the Louisiana State Racing Commission and the Race Meet and Constitutions and agree to be bound by and comply with the same and which the acts and decisions of the Louisiana State Racing Commission and the Horse Racing Officials, and that all animals shall be subject to the same acts and decisions of the officials, and agree to be bound by the following terms and conditions. All stable reservations and entries in Stakes, and all other races, are received and subject to all conditions, rules and regulations of the Louisiana State Racing Commission and the Association where the futurity is to be run.

Elimination Trials

The number of horses in each trial shall be decided by the management. The trials shall be raced under the same conditions as the stakes. The ten fastest qualifiers shall be selected from the trials to participate in the final. If there are more trial races than can be run during one (1) race day, the trial races may be divided and held on separate days. The horses having the five (5) fastest times during the first day of trials and horses having the five (5) fastest times during the second day of trials will qualify for the finals. There will be no "also eligible list" for the futurity final. There will be an "also eligible list" for the Invitational Stakes if needed. Should a horse that has qualified either for the final & stakes race be ruled ineligible to be entered by the Board of Stewards or should the steward scratch a horse from the Sale Futurity final for a rule violation, such horse will be ineligible for any purse money. Purse money due will be divided proportionately among the starters. If a scratch (for reasons other than a rule violation) should occur among the finalists of the Sale Futurity final, the scratched horse will receive last place purse money. If two (2) or more horses scratch from the Sale Futurity final, then the last place purse monies in that race shall be added together and divided equally between the owners of the scratched horses. If the front gates on the starting gate fail to open due to a mechanical failure, or if a horse is left behind the gate when the field is dispatched during the running of the trials such horse shall be declared a non-starter and all nominating, sustaining and entry fees shall be refunded from the purse to the owner of said horse. During the running of the finals, such horse will be declared a non-starter and shall be classified as a scratched horse and shall be paid last place purse money. In the trials horses shall be selected on a time basis. (Time of horses in the trials will be determined only to the limit of the electrical timer. Should a mechanical failure occur with the electrical timer on any trial, finalist for that trial will be selected by stop watch. Exception: Should horses have the same time for the 10th qualifying place in the same race, the winner of that race would have preference. Should a horse be disqualified, he will be given the time of the horse he is immediately placed behind plus 1/10,000 of one second . The decision of the Stewards in all matters shall be final and entries are accepted only on the condition that those persons nominating and/or starting a horse in the trials and/or stakes agree to be bound by their decisions. All trial rules or new rules adopted by the Louisiana State Racing Commission supersede any conditions of this race. The track reserves the right to hold trials on this race as non-wagering or at their discretion .

A 2017 LQHBA Sale Futurity (RG1) will be run for two year olds participants in the 2017 LQHBA Sale Futurity time trials based on the fastest ten qualifying times. Preference for the Invitational Stakes will be given to horses with the fastest nonqualifying times from the LQHBA Sale Futurity trials (11th fastest and down). The will be an "also eligible list" for the Invitational Stakes if needed. Only the first five (5) finishers in the Invitational Stakes will receive purse money.

Louisiana Quarter Horse Breeders Association reserves the right to cancel, postpone or change the location of the race for any reason which it deems good and sufficient. LQHBA shall have the authority to blood test/D.N.A. test the first three (3) finishers and/or all horses entered in this futurity and also reserves the right to have its track veterinarian mouth or inspect any nominee for age any time after arrival of nominees at the track.

An owner may nominate as many entries as desired. If any one or more are withdrawn before the race, be sure to specify which ones are so withdrawn when making payment. Please notify the LQHBA of any sale of nominees or change of address of owner.

Nomination or subscriptions to this stake may be refused or cancelled without any liability at any time prior to the actual running thereof, except for the for the return of any nomination and entry fees paid.

When Time Trials are conducted on two days, the racing secretary shall make <u>his/her best effort to</u> split owners with more than one entry into separate days <u>and/or time trials.</u>
