Consignor Rules & Regulations Eligibility Requirements

- 1. Each horse must be paid to date in the *Estimated Gross Purse \$1,000,000 2015 LQHBA Futurity* (RG1) & Invitational Stakes. All horses entered in this sale and passed through the sale ring, regardless if sold or repurchased, will be eligible for the \$150,000 added *2015 LQHBA Sale Futurity (RG1)*.
- 2. Each consignor must be a current member of the LQHBA. Dues may be paid at time of consignment.
- 3. Consignments must be postmarked or received in the office on or before May 1, 2014, with all required paper work turned into the LQHBA office. There will not be any exceptions!

Each consignment must be accompanied By the following:

(A) Original AQHA Registration Certificate stamped "Parentage Verified"

All consignments must be registered with AQHA at time of consignment. If the parentage verification process is incomplete at consignment deadline, a copy of the AQHA Registration Certificate and the \$300 consignment fee will be accepted. Upon completion of the parentage verification process the original AQHA certificate stamped parentage verified must be submitted to the LQHBA office. All certificates must be in the LQHBA office by Monday, July 14, 2014.

No consignment will be ACCEPTED OR SOLD WITHOUT the Original AQHA Registration Certificate stamped "Parentage Verified".

- (B) Original Louisiana Bred Certificate
- (C) **Signed Transfer Report.** (If more than one owner we need both signatures.)
- (D) <u>Negative Coggins Report</u> (within 6 months) <u>and Health Certificate</u> (only good for 30 days). <u>These two items are to be turned in at the sale on Thursday, August 7, 2014.</u>

Conditions of Sale

- 1. A consignment fee of \$300 will be charged to each consignor plus five percent (5%) commission. THE CONSIGNOR IS RESPONSIBLE FOR THE COMMISSION ON THE ENTIRE AMOUNT THAT THE HORSE GOES THROUGH THE SALE RING FOR. If the AQHA certificate and signed transfer are enclosed at the time of consignment, the fee will not be required until sale date.
- 2. The order of sale positions will be established by public draw. Each consignor will be notified in writing of the date, time and place of the drawing. Consignors are invited to attend but attendance is not mandatory.

- 3. There will be no pass out allowed, but the right to bid is reserved to the consignor.
- 4. Unless otherwise expressly announced at the time of sale, there is no guarantee of any kind as to the soundness or condition or other quality of any animal sold in this sale except that animals, which are unsound of eyes or possess any deviation from the normal in the eyes or are "cribbers" must be so announced at the time of sale. Any animal sold in this sale as a colt and is at such time a ridgeling or gelding, or is described at time of sale as a gelding and is at such time a colt or ridgeling shall be subject to return to the consignor with refund of purchase price. Any animal whose condition is as aforesaid and is not so announced at the time of sale will be subject to return to the consignor with refund of purchase price, provided that written notice of rejection of the animal with such supporting veterinarian's and other certificates as the LQHBA might require within twenty-four (24) hours after the close of the Sale session in which the animal was purchased. If the buyer rightfully rejects the animal in the manner and within the time provided, the animal will be returned by the buyer to the consignor and the consignor will refund to the buyer the full purchase price of the animal together with all reasonable expenses incurred by the buyer in connection with the animal from the time of sale until the return to the consignor. In any case of return of the animal to the consignor in accordance with these conditions of sale, the consignor shall pay all proper expenses incurred on the horse from the time of sale until the return to the consignor. Proper expenses include such items as veterinarian charges, vanning and boarding.
- 5. At the time a horse is checked in, the consignor must furnish the LQHBA with a negative coggins report made within 6 months prior to the sale date along with a current Health Certificate. The health certificate is good for ONLY 30 days.
- 6. The AQHA transfer fee of \$15.00 will be paid by the consignor. The LQHBA will handle the transfer transactions.
- 7. The consignor must leave a good halter and lead rope on the horse after the sale.
- 8. The LQHBA and its employees and auctioneer do not act for or represent either buyer or seller, but merely provide a medium for binding together buyer and seller for the purpose of sale transaction
- 9. All sale <u>updates</u> must be turned in to the <u>sale</u> <u>secretary at least 2 hours prior</u> to the start of the session in which the horse sells.
- ** NOTICE ** If your required Yearling Sale paper work is not complete by May 1st, then you can still pass the yearling through the fall sale ring and be eligible for the Sale Futurity. "Eligibility for the 2015 Sale Futurity includes: (1) being current on the 2015 LQHBA Breeders Futurity and (2) passing through the sale ring at the 2014 Yearling Sale or the 2014 Fall Mixed Sale as a yearling or 2013 Fall Mixed Sale as a weanling.

CONDITIONS OF SALE BIDDERS TAKE NOTICE

CONDITION FIRST: The horses are offered for sale according to the laws of the State of Louisiana.

CONDITION SECOND: There shall be no upset price on the animals entering the sale ring. If an opening bid on any animal is not immediately forthcoming to the auctioneer's call, it shall be passed out of the ring as unsold. The right to bid is reserved for all sellers.

CONSDITION THIRD: The highest bidder is to be the buyer, and if any dispute arises between two or more bidders, the horse in dispute shall be immediately put up again for advance bids. If there be no advance, then the horse shall go to the person from whom the auctioneer recognized the last bid. The auctioneer reserves the right to reject any or all bids.

CONDITION FOURTH: Horses will be held at buyers risk and expense from time of sale. NO DELIVERY WILL BE MADE UNTIL FINAL SETTLEMENT. All horses purchased shall be subject to stable charges for each day or fraction thereof from twelve o'clock noon of the day following sale.

CONDITION FIFTH: PAY CASHIER IN ALL CASES. In no cases shall any part of purchase money be paid by the buyer to consignor, as such payment will not be regarded as valid or entitle buyer to delivery of the horse. On final payment for a horse, the cashier of the Louisiana Quarter Horse Breeders Association will issue an order which must be presented by the buyer to the stable manager for its delivery. Buyers are cautioned not to lose these orders.

CONDITION SIXTH: Terms of sale are CASH or APPROVED CHECKS, and payment in full MUST BE MADE TO THE CASHIER IMMEDIATELY AFTER SALE, subject to CONDITIONS SET FORTH HEREIN.

CONDITION SEVENTH: SHOULD BUYER FAIL TO COMPLY IN ANY RESPECT WITH CONDITIONS SET FORTH HEREINABOVE, THE LOUISIANA QUARTER HORSE BREEDERS ASSOCIATION MAY, IN ITS ABSOLUTE DISCRETION, PURSUE ANY REMEDY AVAILABLE AGAINST THE DEFAULTING BUYER, INCLUDING BUT NOT LIMITED TO, TAKING POSSESSION OF THE HORSE, RESALE OF THE HORSE AT PUBLIC AUCTION OR BY PRIVATE AUCTION OR BY PRIVATE TREATY FOR ACCOUNT OF DEFAULTER. In any such case defaulter shall be liable for any deficit in his account after charging to his account all cost of maintenance and resale, including but not limited to, service charges, attorneys fees, costs of litigation, and damages available to undersigned by law.

CONDITION EIGHTH: If any person shall purchase a horse and fail to pay for it within the time limited herein, nothing contained in the CONDITIONS shall prevent the auctioneer, Louisiana Quarter Horse Breeders Association, or the consignor from compelling such person to pay for it.

CONDITION NINTH: Quarter Horse registration papers will be forwarded to the A.Q.H.A. as soon as purchase price has been paid in full.

CONDITION TENTH: UNLESS EXPRSSLY ANNOUNCED FROM THE AUCTION STAND, OR BY OFFICAIL PUBLICATION OF THE LOUISIANA QUARTER HORSE BREEDERS ASSOCIATION, OF AS HEREINAFTER PROVIDED, THERE IS NO WARRANTY OR GUARANTEE OF ANY KIND AS TO THE SOUNDNESS OR CONDITION OR OTHER QUALITY OF ANY HORSE SOLD IN THE SALE.

Any animal whose condition is as aforesaid and is not so announced at time of sale will be subject to return to consignor with refund of purchase price, provided that the Louisiana Quarter Horse Breeders Association is so notified in writing and shall be within forty-eight (48) hours after the start of the session at which the animal in question was sold.

CONDITION FOURTEENTH: The Auctioneer and Louisiana Quarter Horse Breeders Association are not responsible for statements in this catalog concerning horses listed herein for sale, nor for any warranties concerning these horses. Horses listed in the catalog are sold with engagements listed herein or announced at the time of sale and such information being as represented by consignor to whom only the purchaser shall look for redress in case of errors or omissions. The auctioneer and Louisiana Quarter Horse Breeders Association shall endeavor to have all pedigrees and engagements correctly stated, but are not responsible for errors or omissions.

CONDITION FIFTEENTH: If any check, account or contract is not paid within fifteen (15) days after receipt, it will be placed in the hands of an attorney for collection or enforcement. Purchaser agrees to reimburse Louisiana Quarter Horse Breeders Association for all costs thereof, including fees paid by it.

CONDITONS SIXTEENTH: Horses catalogued in this sale are offered as represented by consignor, and auctioneer and the Louisiana Quarter Horse Breeders Association are not responsible for the accuracy of information provided. While certain information may have been procured by auctioneer from third parties on behalf of consignor, it is nonetheless solely the responsibility of consignor to verify the accuracy of such information and to notify the auctioneer of any corrections prior to sale.

CONDITION SEVENTEENTH: The Louisiana Quarter Horse Breeders Association or auctioneer shall not be bound by any oral or written agreement or alleged agreement varying from these CONDITIONS OF SALE between the buyer and the consignor unless agrees to by the Louisiana Quarter Horse Breeders Association, and any controversy or claim between the buyer and the consignor arising under any such agreement shall be a matter for their resolution.

SPECIAL NOTICES READ CAREFULLY

CARE OF HORSES AFTER SALE: Although it is the consignor's responsibility to provide care and feed for horses until noon the day following purchase, please be reminded that title passes at the fall of the hammer at which time the purchaser assumes all risk and responsibility for the horse. Purchasers are advised to contact the consignor to confirm that proper care is being provided. ALL HORSES MUST BE MOVED FROM THE SALE PREMISES BY NOON OF THE DAY FOLLOWING THE LAST SESSION.

ALL ACCOUNTS MUST BE PAID IN CASH AT TIME OF SALE, unless satisfactory credit has been established. In case of default, cost of collection, including all attorneys' fees, will be assessed to the buyer. Credit cards are NOT an acceptable method of payment.
